Subject: Coronavirus (COVID-19) - Designation of seafarers as key workers by the Arab Republic of Egypt.

Within our efforts to alleviate the repercussions of COVID-19 pandemic and in compliance with the IMO and other concerned international Organizations' instructions, protocols and guidelines to sustain the global chain of supplies and ensure safe crew changes and repatriation, the Maritime Transport Sector, Egypt, would like to express its appreciation to the IMO and notify your esteemed Organization that the Arab Republic of Egypt designates Seafarers as key workers.

We would like to reiterate that we have taken all necessary measures to mitigate the consequences of the pandemic on the maritime sector and to facilitate the safe repatriation of seafarers.
