Subject: Extension of the validity of endorsements during the coronavirus (COVID-19) outbreak, designation of seafarers as key workers and Finlands National Focal Point on Crew Change and Repatriation of Seafarers

Dear Secretary-General,

With reference to the Circular Letters 4260 and 4260/Add.1 regarding extension of the validity of maritime personnel certificates during COVID-19 outbreak, I would like to further update you on the measures taken by Finland.

Due to the COVID-19 pandemic, appropriate and necessary changes have been made in current legislation on a temporary basis. In addition to the measures referred to Finland's response dated 10 June 2020, the Finnish Parliament has decided to accept an amendment regarding the validity of seafarers' endorsements. The amendment entered into force 1 January 2021.

By this amendment, the Finnish Transport and Communications Agency may temporarily grant extensions on the validity of seafarers' endorsements. The validity of the endorsements may be extended in accordance with the period of validity of the underlying qualifications. However, the extensions may only be valid until the end of June 2021 at the latest, and the total period of validity of the endorsement should not exceed five years.

Finland also plans to make further extensions on seafarers' Certificates of Competency and Certificates of Proficiency.

In addition, I would like to inform you that on 16 March 2020 Finland designated professional seafarers and marine personnel, regardless of their nationality, as 'key workers' providing an essential service. With reference to the IMO MSC resolution MSC.473(ES.2) and Circular Letter MSC.7/Circ.1/Rev.19, please find attached the contact information of Finlands National Focal Point on Crew Change and Repatriation of Seafarers.
